9. I agree to involve CAWS in any decision to euthanize, unless the dog has been severely injured and contacting CAWS would prolong suffering. If there is a disagreement on the decision to euthanize, CAWS reserves the right to reclaim the dog.

10. I understand that CAWS places the dog with no warranty as to the physical condition or temperament of the dog. I accept this dog as is with all defects, either observable or unobservable, and assume all risk for such dog from the date of signing of this contract. I hereby release CAWS from any claim, cause of action, or liability for any injury or damage to persons or property once the animal is in my possession.

11. I will assume all responsibility for the dog's actions after the effective date of this Contract. I agree to hold CAWS and its representatives harmless; from any and all liability associated with any illness of the dog, or damage or injury caused hereafter by the dog.

12. I understand that CAWS cannot vouch for the temperament, health, or line of the dog, as the dog may have been in an unusual situation and in many cases with history, and may not show its true nature or health for some time after placement.

I understand that CAWS reserves the right to reclaim the animal at any time if it comes to their attention that circumstances exist that would make the adoptive home unsuitable for the animal. I agree that if CAWS should determine at any time that any of the provisions of this agreement have not been complied with, I will return the animal to CAWS upon demand. I authorize CAWS, at its sole discretion, to determine whether or not the pet has been abused or neglected. I understand that there may history with the animal that is unknown to CAWS. CAWS also reserves to right to conduct a follow-up visitation at any time. I agree to furnish the animal with acceptable veterinarian care. I will not sell the animal or give it to an unsuitable home. If I am unable to keep the animal, I will return it to CAWS.
